Also I served before as a Associate Dean for Community Service and Environmental Development and before that I served as Head of the Administrative Sciences Department at the Faculty of Technology and Development - Zagazig University.
- Establishing and implementing an integrated e-learning platform and system for the Faculty of Technology and Development using the Moodle system (www.arab-bisc.net) to meet the requirements of online education due to the Corona pandemic. The system successfully handled all students' practical exams and training programs, as well as assignments, exercises, lectures, and others for more than 400 courses for 3800 students for the Faculty. At the present time the platform is being used for our e-learning practices and for the distribution of the e-book to students.

The project was fully implemented in terms of material projects.

supervisor of the Department of Administrative Sciences in the Faculty, I am carrying out executive tasks as the general supervisor of two undergraduate programs in the department.
